Letter from Executive Director

2021 and 2022 were very exciting years for Arapahoe Community College and the Arapahoe Community College Foundation. President Dr. Diana Doyle retired after serving as ACC's President for 11 years and Dr. Stephanie Fujii started her Presidency in July 2021. The ACC Foundation Board of Directors took the opportunity to revisit mission and programs during a retreat in October 2021. The day was very productive with a new mission statement approved: *The Foundation works to advance the mission of the college by providing financial assistance and opportunities to students, encouraging public support for the college, and strengthening the teaching, learning and cultural environment of the college and our community.* The Foundation Board also specifically defined Foundation Programs:

- **Scholarships are a major focus for the ACC Foundation.** Scholarships make the difference for a student being able to enroll at ACC or to finish their degree. During the past fiscal year, the ACC Foundation awarded over \$1 million in scholarships. Nearly 60% of recipients are First Generation College Students and over 83% persist semester to semester. 46.8% plan to transfer to a four-year institution after completing requirements, 40.2% say they plan to enter the workforce right away or came to ACC to increase their earning potential
- **Student Emergency Fund.** The intention of the Student Emergency Fund is to assist students with emergencies – food, shelter, utilities and other living expenses, emergency transportation, etc. The Student Emergency Fund continues to be utilized by students who have unexpected situations arise that put them in a position of needing financial assistance. This account is managed by the ACC Foundation and monitored by the Dean of Students Office. It is funded through fundraising and employee payroll contributions. During the past fiscal year, the ACC Foundation provided over \$50,000 for this fund.
- **Mini-Grants for Innovation allow ACC's faculty and staff to submit innovation ideas to pioneer new projects or fund special initiatives that support ACC mission.** The ACC Foundation awards \$25,000 annually to faculty and staff to realize these projects. Examples of past awards include the creation of a student food pantry, the purchase of a robotic arm for the Robotics Program, care packages for student workers and more.
- **Sturm Collaboration Lift the Gift.** In March 2019, Arapahoe Community College received a gift of up to \$10 million from the Sturm Family Foundation, the largest in the history of the 13-institution Colorado Community College System. With an over \$5 million match opportunity, bringing the full potential of the gift in excess of \$15 million, the funding will be used in its entirety for ACC's new Sturm Collaboration Campus at Castle Rock. Matching dollars raised by the ACC Foundation will be used in 3 unique areas: the program innovation fund, an endowed scholarship fund, and an investment in the future Phase II of the campus.
- **Other ways the ACC Foundation brings mission to life include:** Received funding for ACC's Health Innovation Center: a simulation wing offering hands-on experience in emergency health services. Launched an alumni network platform to provide mentoring opportunities, manage alumni events via one central portal, and help ACC alumni connect with one another. Launched the Forever ACC Legacy Society to honor and recognize those who create a legacy gift to support the College. Grew partnerships with important leaders in industry and philanthropy such as Lockheed Martin, HCA/HealthOne, Centura Health, Sturm Family Foundation, Anschutz Family Foundation, and ZomaLab. Secured multiple grants to support student success.

This work can not be done without the support and investment of ACC's many friends and family who are listed in this annual report. We are forever grateful to each and every one of these amazing individuals, organizations and foundations.

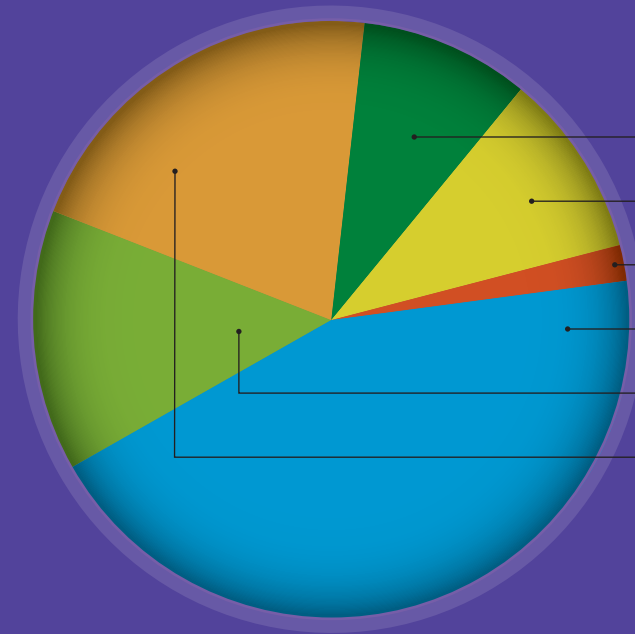

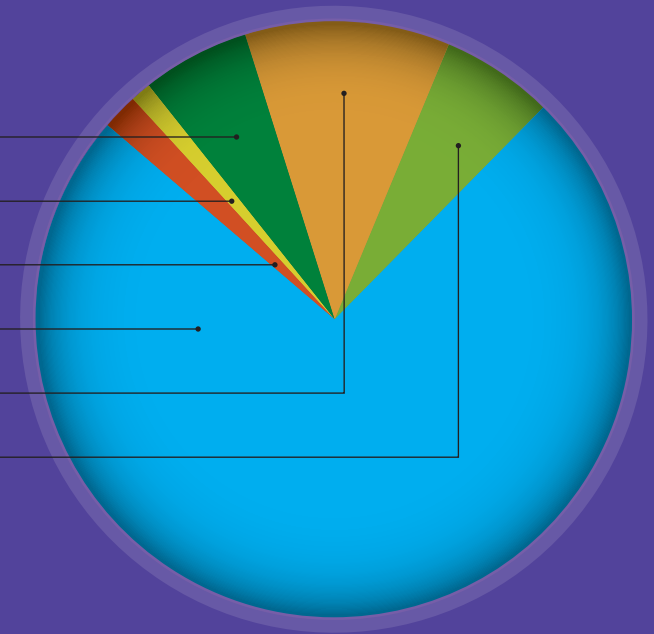
