

Affidavit of Financial Support

Arapahoe Community College requires evidence and signed statements of financial support from all current and prospective F-1 status students. Students must provide proof of adequate financial resources to pay for one year (12 months) of estimated academic and living expenses (cost of attendance) without the need to resort to unauthorized employment. On-campus employment is extremely limited and off-campus employment is strictly controlled by U.S. Citizenship and Immigration Services.

A Form I-20 will be issued only if ACC has assurance that the student has full financial support for their education. **BOTH the student AND any sponsor(s)/supporting family member(s) who provide bank statements/bank letters MUST sign this form.**

SECTION 3 – Proof of Financial Support

Financial Evidence supporting documents must meet all of the following criteria:

- Bank statement(s) on original bank letterhead or Signed and Certified bank letter/statement of savings on original bank letterhead. Provided accounts must have liquid funds available.

Financial documents that will NOT be accepted include:

- Checking account statements with rolling balance
- Pay stubs, annual salary statement or credit card statements
- Accounts that will not allow withdrawals (ie. Real estate investments, stocks, insurance, investments, etc.)

Statements/Bank Letters must be in English (attach certified translation if applicable)

Statements/Bank Letters must be less than 6 months old from the date of application
